Maine HIE to pilot nation's first statewide medical image archive

Maine's HealthInfoNet will [launch](#) the first medical image archive in the U.S. The new service "will reduce the cost of storage and transport of electronic medical images and make sharing these images possible through the health information exchange (HIE). In addition to leveraging the HIE, the service prepares Maine's providers for sharing images through the NwHIN Direct and Connect systems. It also supports the development of Accountable Care Organizations and other shared risk model care delivery structures." HealthInfoNet expects to end the pilot phase in the fall and expand the service statewide by 2013. [Read More](#)
